

**EATON SCHOOL BOARD**  
**APRIL 4, 2016**  
**MINUTES**

PRESENT: Chris Kennedy, Monique Hebert, September Quint, and Kevin Richard.

1. Superintendent Kevin Richard called the meeting to order at 6:00 p.m.
2. Reorganization of Board
  - A. Election of Chairperson – Mr. Richard asked for nominations for Chairperson. **September Quint made a motion to elect Chris Kennedy as Chairperson. The motion was seconded by Monique Hebert and passed 3-0-0.** Mr. Richard turned the meeting over to Chair Kennedy.
