# PERMIT FOR USE OF TOWN LANDS AND FACILITIES

## TERMS AND CONDITIONS

1. Use under this Permit, allowed for a number of people not to exceed 15, will begin on \_\_\_\_\_, and end on \_\_\_\_\_. The permit is issued for only the date(s) listed here and will not be extended.
2. The holder of this permit will conduct only those activities authorized by this permit. Those activities, approved by the Select Board, must be attached to this permit.
3. The holder of this permit will not install any improvements not specifically identified in the attached, approved activities. Any permitted improvements will become the property of the Town of Eaton, unless otherwise specified.
4. No soil, trees or vegetation may be destroyed or removed from Town lands without specific prior permission of the Select Board.
5. No campfires or fireworks are permitted.
6. The holder of this Permit will comply with all Federal, State, County and Municipal laws, ordinances and regulations that are applicable to the area covered by this permit.
7. At the conclusion of the activities specified, the holder of this Permit will ensure that the area covered by this Permit is returned to its original state prior to the activities permitted. Furthermore, the permit holder will fully repair and bear the expense of all damage, other than ordinary wear and tear to Town lands, roads and trails, that may result from the permitted activity.
8. The holder of this Permit will provide, at his/her expense, all necessary sanitation facilities.
9. The holder of this Permit will be responsible for removing all trash from the site at the conclusion of permitted activities.
10. The holder of this Permit will be liable for any damage suffered by the Town resulting from, or related to, use of this permit, including damages to Town resources, costs related to returning the site to its original state prior to the activities permitted, or in the case of fire that may result from the use of Town lands by the activities attached, any costs related to fire suppression.
11. The holder of this Permit is responsible for inspecting the use area and adjoining areas to ensure the safety of participants.
12. The holder of this Permit will hold the Town of Eaton harmless from any liability from damage to life or property arising from the use of Town lands.

13. During the permitted times of use as stated in item #1 of this Permit, the holder agrees to permit the free and unrestricted access to the area by the general public.
14. This permit is subject to all valid, existing rights and claims outstanding in third parties.
15. This Permit may be revoked at any time, upon breach of any of the conditions herein, or at the discretion of the Select Board.
16. This permit is not transferrable.
17. If the holder of this Permit is a business, the Select Board reserves the right to require of the holder any schedule of prices for services authorized by this permit.
18. Insurance – The holder of this Permit will have in force public liability insurance covering all those insurance requirements listed on page 2 of the Town’s Ordinance #4 entitled *Regulation for the Use of Town Lands*.

Rider Clause (for insurance companies)

It is understood and agreed that the coverage provided under this policy will not be cancelled or its provisions changed or delete before thirty days of receipt of written notice by the Select Board, Town of Eaton.

This Permit is accepted, subject to the conditions set forth herein. The conditions and exhibit, (i.e., the activities authorized by this Permit) are attached to and made a part of this permit.
